I confirm that Gilshenan and Luton acts for BMD in relation to your investigation into an alleged incident involving Cody Raymond on 5 June 2024.

Thank you for your time on the phone last week in relation to the email that was sent by you to Steve Thomas of BMD on 24 November 2024.

It is noted that you have requested from our client:

1. CCTV footage of incident on 05 June 2024. Information received is that the incident occurred between 12pm and 1pm;
2. All CCTV footage on site on 05 June 2024 from start of work until completion of work;
3. Employee details for Host Group or Host Group Australia Pty Ltd;
4. Any other material held by BMD and relevant to the investigation.

CCTV Footage

I have been instructed that our client only has access to an online portal where CCTV footage can be viewed. A search of the portal has been undertaken and the most recent footage that is able to be viewed is for dates in August 2024. Accordingly, our client is unable to assist your investigation with the provision of CCTV footage from 5 June 2024 of an alleged incident, or from the site generally.

During our call I indicated that I would make enquiries as to how the CCTV footage had been provided to Georgiou for their investigation. I understand from my enquiries that Georgiou had access to the same online portal and that a copy was not provided on removable media.

Host Group

Host Group is engaged as a third-party security provider engaged at the Centenary Upgrade Project at Jindalee. Accordingly, any employee details will be held by Host Group and our client does not have anything to produce in response to this aspect of your request.
